7. Your Fire & Rescue Service 2025/28 Consultation & Engagement Plan

Members considered a report from the Director of Service Support which provided an overview of the Consultation and Engagement Plan which will support the development of 'Your Fire & Rescue Service 2025/28'.

Members challenged the report author on how the consultation would be presented in order to reach underrepresented groups and if there were any plans to review the progress made in this area post consultation. Members were further interested to learn about local businesses, external partners and stakeholders and their classification. Members requested and were given, information regarding the task and finish group, the timeline for the consultation and the post consultation review.

Members were advised the Say So system is due to be relaunched on a new and improved platform which will be able to analyse the data better and monitor any emerging trends.

Members recognised the excellent work done to achieve the compliance plus ratings and were pleased to see the number of compliments received and welcomed the confirmation that all complaints are investigated fully and the outcomes acted upon.
