Members received a report from the Deputy Chief Fire Officer which summarised the Authority's performance against key performance indicators for the period 1 April 2023 to 31 March 2024 and detailed the Authority's performance against key performance indicators for the period 1 April 2024 to 18 June 2024. Members noted and discussed the following:

• That the number of fire related fatalities has increased in 2023/24

- That despite a peak in the number of false alarms in Wakefield during 2023/24, the figure has reduced for the year to date.
- Clarification of safe and well visits, the partnerships fostered with the voluntary sector, NHS, police etc and the focus on risk areas.
- Attacks on Firefighters and the work done throughout the year with local community groups.
- The introduction of body worn cameras to provide evidence of such attacks to support prosecutions and the work done with perpetrators through victim education and restorative justice.
- Number, location and severity of fires connected with to lithium batteries and the progress of work focused in this area.
- The variance in response times across all districts due to varying nature of the population and landscape.
- Fire related injuries by age.
- The increase in water related fatalities and the presence of Firefighters at hot spots during periods of hot weather.
